## NATIONAL ACADEMY OF BIOLOGICAL SCIENCES [NABS]

### I. Guidelines to Applicants

- The application is evaluated based on the Score Card System developed for the purpose.
- Accomplishments / achievements based on the documented evidences are given marks as per SCORE CARD SYSTEM.
- CREDENTIALS claimed without evidence(s) shall not be considered.
- GIVE THE PAGE NUMBER OF THE EVIDENCE PROVIDED AT APPROPRIATE COLUMN OF THE APPLICATION

#### A. Research Accomplishments

- List publications with full citations (full name of the Journal should be given while listing) in reputed high impact journal- international or national;
- Total number of listed publications should not exceed 20 including national and international publications.
- Provide IMPACT FACTOR (IF) for each of the paper published. [indicate the data base for the IF)

## Research publications of the nominee shall be evaluated based on the following criteria:

- Seniority of authorship; in case of multiple authors, first two authors will get full marks; rest of the authors will get half of the marks allotted.
- Corresponding author(s) are considered as senior authors.
- The applicant is also advised to provide impact factor for publication listed
- Provide copy of the first page of each publication showing author(s), title of paper, year, volume and page number

#### B. Educational Accomplishments

- 1. **Each book,** either **sole author(s)** or **edited**, shall have the ISBN number with not less than 200 pages published by a reputed publisher.
  - Provide Xerox copy of the first page of book showing, author(s), publishers, page numbers (essential parameters) etc.
  - Provide copy of the page where ISBN number is given in the book.
- 2. **Each Book chapter** appearing in an edited book (with ISBN number with not less than 200 pages published by a reputed publisher) shall also be considered as a publication and marks allotted accordingly.
  - Provide Xerox copy of the first page of the chapter with the first page of edited book in which the chapter(s) appeared.

3. **Number of Ph.D Students guided-** provide the list of theses with evidence. Only theses awarded with Ph.D alone are to be given; C. **Externally funded schemes** Provide appropriate evidence(s) List schemes with funding of Rs. 10.00 lakhs and above obtained on a competitive basis as Principal Investigator. Do not include ICAR coordinated projects or projects sanctioned to the University / Institutions. Copy of the letter of sanction of the scheme from the funding agency shall be the evidence. The copy of the communication from the Institution alone is not sufficient. D. Crop varieties / breeds /products / technologies /patents Provide appropriate evidence(s) Number of crop varieties/breeds released Proper evidences shall be provided for the claim made in application as per details asked for. Number of products/technologies developed Products envisages-machineries, ergonometric machineries, bio-formulations, new models or modules to understand the concepts, soft- ware to solve problems, interactive multimedia, new microbes, pests, pathogens plants, animals, identified. The product developed shall have an impact on the relevant fields of applications. The technologies so developed shall become a sustainable practice by stakeholders- IPM / INM strategies/ animal improvement, innovative extension practices etc., leading to large scale diffusion and adoption. Number of patents obtained Patents granted with File Number, Patent Number, accession number shall be provided: Trademarks, GI, Germplasm registration, IP protection etc., will also be considered. E. Other academic achievements Provide appropriate evidence(s) Awards / Medals received Note: Awards / Medals received during the study periods (UG, PG, Ph.D.) will not be considered. Awards and Medals should have been received from well recognized academies/ institutions /organizations / Universities / State and Central Governments/ National level professional societies, Best teacher, researcher or extension worker award, Young Scientist award, D.Sc, etc. Awards of ICAR, CSIR, DST, DBT, ICMR, NABS, NAAS, NAVA, NASI will also be considered. International awards like Humboldt, Fulbright, DAAD Fellowship and awards of DBT Overseas award, INSA award will also be considered. Fellow of National / International Academies / Societies Recognition as a Fellow of National /international academies / Societies is considered.

F. **Academic / Research Leadership** Providing leadership in taking forward the research activities of his discipline, organizing summer /winter schools, organizing special skill trainings to teachers, students /organizing Seminars / Symposia / Conferences shall be considered. - v. Before sending the filled in application cum nomination, **tick** mark the check list and enclose along with application.
- vi. Prepare a content page and put before the Nomination Proposal.
- vii. Serially number all the pages starting from Nomination Proposal.
- viii. Enclose supporting evidences for every claim at the end of the application as Annexure(s) which are to be serially numbered.

#### 3. Eligibility

All life members of NABS who have completed 30 years as on 1<sup>st</sup> December, 2017 and have completed a \*cooling period of SIX months are eligible. [\*From the date of your enrollment as Life member, SIX months should have been completed as on 1<sup>st</sup> December, 2017].

Note: Provisional Life Members are not eligible.

4. Registration and Processing Fee [R & PF] [Non-refundable] shall be paid only online with proper evidence enclosed along with the application.

Nominee shall enclose evidence for having transferred the R& PF fee of Rs. 3000/- (Rupees Three thousands only) online to the account of **National Academy of Biological Sciences** payable at Chennai

#### 5. Role of Forwarding Authority
